

**SUMMARY ANNUAL REPORT  
For**

**Marsh & McLennan Companies, Inc. Employer Funded Welfare Benefit Plan**

This is a summary of the annual report of the Marsh & McLennan Companies, Inc. Employer Funded Welfare Benefit Plan, EIN 36-2668272, Plan No. 501, for period January 1, 2011 through December 31, 2011. The annual report has been filed with the Employee Benefits Security Administration, U.S. Department of Labor, as required under the Employee Retirement Income Security Act of 1974 (ERISA).

**Insurance Information**

The Plan has contracts with Metropolitan Life Insurance Company, Hawaii Medical Service Association, and Kaiser Foundation Health Plans Inc. to pay health, life insurance, HMO and PPO claims incurred under the terms of the Plan. The total premiums paid for the Plan year ending December 31, 2011 were \$7,348,362.

Because they are so called "experience-rated" contracts, the premium costs are affected by, among other things, the number and size of claims. Of the total insurance premiums paid for the Plan year ending December 31, 2011, the premiums paid under such "experience-rated" contracts were \$4,084,043 and the total of all benefit claims paid under these contracts during the Plan year was \$4,331,351.

**Basic Financial Statement**

The value of Plan assets, after subtracting liabilities of the Plan, was \$84,305,132 as of December 31, 2011, compared to \$53,117,909 as of January 1, 2011. During the Plan year the Plan experienced an increase in its net assets of \$31,187,223. This increase includes unrealized appreciation and depreciation in the value of Plan assets; that is, the difference between the value of the Plan's assets at the end of the year and the value of the assets at the beginning of the year or the cost of assets acquired during the year. During the Plan year, the Plan had total income of \$232,332,106, including employer contributions of \$147,247,294, employee contributions of \$85,158,768, losses from investments of \$73,956, transfers from the Marsh & McLennan Companies Employee-Funded Welfare Benefits Plan of \$29,871,433, and transfers to the Marsh & McLennan Companies Comprehensive Medical Plan of \$482,703.

Plan expenses were \$230,533,613. These expenses included \$13,537,073 in administrative expenses, and \$216,996,540 in benefits paid to participants and beneficiaries.

The charge to cover copying costs given above does not include a charge for the copying of these portions of the report because these portions are furnished without charge.
