## HelloWallet

*HelloWallet is a Web and mobile based application leveraging the latest research in behavioral science to provide you with personalized financial guidance to help you manage your expenses and find more money in your paycheck to grow savings, pay down debt, and plan for the future.*

### Plan Summary

This section provides a summary of HelloWallet as of January 1, 2016.

HelloWallet is not governed by the Employee Retirement Income Security Act of 1974 (ERISA). For example, ERISA requirements such as providing a Summary Plan Description, filing an annual report (Form 5500 Series), or making a summary annual report available do not apply to HelloWallet.

## Participating in HelloWallet

The following section provides information on how you start participating in HelloWallet.

If you are an employee of Marsh & McLennan Companies or any subsidiary or affiliate of Marsh & McLennan Companies and you meet the requirements set forth below, you become eligible on your eligibility date. Once you become eligible, you will receive an email from HelloWallet that invites you to create your account.

### Eligible Employees

To be eligible for HelloWallet, you must meet the eligibility criteria listed below.

#### *Marsh & McLennan Companies Employees (other than MMA or Mercer PeoplePro)*

If you are at least 18 years of age, you become eligible to register an account with HelloWallet as soon as you are classified on payroll as a US regular or temporary employee (including US expatriates) of Marsh & McLennan Companies or any subsidiary or affiliate of Marsh & McLennan Companies (other than MMA and any of its subsidiaries or Mercer PeoplePro).

Individuals who are compensated as independent contractors are not eligible to participate.

#### *MMA Employees*

If you are at least 18 years of age, you become eligible to register an account with HelloWallet as soon as you are classified on payroll as a US regular or temporary employee (including US expatriates) of Marsh & McLennan Agency LLC – Corporate (MMA-Corporate), Marsh & McLennan Agency LLC – Alaska (MMA-Alaska), Marsh & McLennan Agency LLC – Southwest (including Prescott Paillet Benefits) (collectively MMA Southwest) (MMA-Southwest), Marsh & McLennan Agency LLC – Northeast (MMA-Northeast), or Security Insurance Services of Marsh & McLennan Agency.

Individuals who are compensated as independent contractors are not eligible to participate.

### Your Eligibility Date

If you meet the eligibility requirements, you are immediately eligible.

### When Coverage Starts and Ends

You are covered under HelloWallet on the date you meet the eligibility requirements.

#### **“You,” “Your,” and “Employee”**

As used throughout this plan summary, “employee,” “you” and “your” always mean:

- For Marsh & McLennan Companies participants: a US regular or temporary employee of Marsh & McLennan Companies or affiliate of Marsh & McLennan Companies (other than Marsh & McLennan Agency LLC and any of its subsidiaries (MMA) or Mercer PeoplePro) on a US payroll.
- For MMA participants: a US regular employee of MMA-Corporate, MMA-Alaska, MMA-Southwest, MMA-Northeast, or Security Insurance Services of Marsh & McLennan Agency.

Coverage ends on the date when the first of the following occurs:

- you no longer meet the eligibility requirements
- you terminate employment
- your death
- the tool is terminated.

## **Cost**

There is no cost to you for using HelloWallet. HelloWallet is funded by Marsh & McLennan Companies.

## **Converting to Direct Bill**

### ***Upon termination, can I convert this coverage to direct bill?***

Yes. Upon termination, you will be given the option to cancel your HelloWallet account or sign-up for public account direct billing for which you'll receive an extra 30 days of free usage. You will then be charged the market rate and billed monthly by HelloWallet starting on the 31<sup>st</sup> day and each month thereafter.

## **How HelloWallet Works**

The HelloWallet website serves as a cost effective, easy to use online planning tool that delivers highly personalized financial guidance and puts you in control of your saving and spending. Powerful analytics combine with simple, friendly interface to demystify financial management and engage you in making wise, day-to-day decisions about your money. The website is intended to provide you with general educational information based on personal financial information you choose to input and your own personal circumstance and expectations for the future. HelloWallet offers unbiased support because they are independent from all financial institutions, credit unions and 401(k) providers.

### ***When calling HelloWallet, what information will I need to provide?***

You will need to provide your email and zip code associated with your HelloWallet account.

### ***Do I have to follow the recommendation of HelloWallet?***

No, you remain in full control of your financial decisions. The information you receive from HelloWallet is not intended to provide any personal advise, including investment, tax, legal, and/or financial planning advice. You are responsible for making decisions that are best suited for your personal needs, preferences and financial situation.

### ***Do I have to use this tool?***

No. Participation is completely voluntary.

***If I have an authorized unpaid leave of absence or become disabled, can I still participate in HelloWallet?***

During a period of authorized leave of absence or disability, you will remain eligible for the benefit.

***What happens to my data upon termination?***

You will have 30 days to elect to continue service on a direct bill basis. Once you access your online account via [www.hellowallet.com/mmc](http://www.hellowallet.com/mmc), you will be given instructions on how to continue the benefit.

***Can I change my log-in email address?***

Yes. Once your account has been created with your Marsh & McLennan Companies work email address, you will be able to change your address at any time by clicking on the Profile tab in HelloWallet.

***Can anyone in my family open a HelloWallet account as well?***

No, only eligible Marsh & McLennan Companies employees will be able to create a HelloWallet account. However, you may easily include your family's finances in your existing account. HelloWallet has been designed to easily track your family's finances in addition to your own.
