

SUMMARY ANNUAL REPORT

For Marsh & McLennan Companies, Inc. Health & Welfare Benefits Program

This is a summary of the annual report of the Marsh & McLennan Companies, Inc. Health & Welfare Benefits Program, EIN 36-2668272, Plan No. 501, for period January 01, 2017 through December 31, 2017. The annual report has been filed with the Employee Benefits Security Administration, U.S. Department of Labor, as required under the Employee Retirement Income Security Act of 1974 (ERISA).

Insurance Information

The plan has contracts with Genworth Life Insurance Company, Metropolitan Life Insurance Company, Hawaii Medical Service Association, Hartford Life And Accident, Kaiser Foundation Health Plans Inc., Kaiser Foundation Health Plan of Colorado, Kaiser Foundation Health Plan of Georgia, Kaiser Foundation Health Plan of The Mid-Atlantic, and Kaiser Foundation Health Plan of The Northwest to pay health, life insurance, long-term disability, HMO, PPO, and Long Term Care claims incurred under the terms of the plan. The total premiums paid for the plan year ending December 31, 2017 were \$20,788,013.

Because they are so called "experience-rated" contracts, the premium costs are affected by, among other things, the number and size of claims. Of the total insurance premiums paid for the plan year ending December 31, 2017, the premiums paid under such "experience-rated" contracts were \$4,496,222 and the total of all benefit claims paid under these contracts during the plan year was \$6,106,008.

Basic Financial Statement

The value of plan assets, after subtracting liabilities of the plan, was \$86,999,270 as of December 31, 2017, compared to \$78,575,811 as of January 01, 2017. During the plan year the plan experienced an increase in its net assets of \$8,423,459. This increase includes unrealized appreciation and depreciation in the value of plan assets; that is, the difference between the value of the plan's assets at the end of the year and the value of the assets at the beginning of the year or the cost of assets acquired during the year. During the plan year, the plan had total income of \$250,817,890, including employer contributions of \$164,123,473, employee contributions of \$78,600,266, retired employee contributions of \$3,442,935, and earnings from investments of \$4,651,216.

Plan expenses were \$242,394,431. These expenses included \$10,306,979 in administrative expenses, and \$232,087,452 in benefits paid to participants and beneficiaries.
